Cub Adventure Day Health and Safety Plan

Before Arrival:

Paperwork Required upon Arrival:

- Youth Waivers
- Adult Waivers
- BWC Health Screeners

Items Required for Entry:

- Face Covering

Have parents take all family members temperatures before leaving for camp. If you or a family member temperature is over 100.4, then we ask that your family stays at home.

At Arrival:

- Have completed required forms ready to turn in.
- You will then be directed to park.

Check-In Process:

- There will be 4 lines for check-in. Families will be standing 6 feet apart from other families and wearing face covering.
- The grass will be marked every 6 feet on the parade field.
- Families will tell name and then if they pre-registered, they will be handed an event packet. If did not pre-register they will pay \$18.00 (Prairie \$13.00) for walk up registration and then receive an event packet.

*Event Packet has patch, schedules, map, wrist bands and fishing lure.

*There will be a separate line for those who have not pre-registered.

- Each paid participant will receive event packets containing fishing lures, patches and schedules.
- After receiving the event packet, family will report to their assigned number on the parade field and then wait for the opening ceremony.

Opening Ceremony:

- Families will remain on the parade field during opening ceremony.
- After the opening ceremony, each group of ten will report to their first activity
- Groups will then be assigned a program area as their starting point.

Activities:

- Each group of 10 and will rotate every 25 minutes.
- A bell will sound when it is time to rotate. Please do not rotate prior to the bell.

- While families wait for their scout during the activity, they must maintain a 6 feet distancing, if they do not stay the recommended 6 feet, they must be wearing a mask within 6 feet of other families.
- We will have monitors making sure that these guidelines are followed.
- While groups are rotating, the equipment and supplies used, will be wiped down and sanitized for the next group to use.
 - a. Equipment to be wiped down and sanitized are bb guns, bows and arrows, slingshots, craft tools like scissors, markers, pens and pencils.
 - b. Groups should take crafts that were made with them.
- Hand sanitizing stations will be located in each program area.

Lunch:

- Lunches will be boxed and be picked up by each parent who has an arm band at the dining hall patio.

Fishing Derby:

- Families must stay 6 feet apart from other families to reduce the risk of spreading the virus to other families.
- Families must bring their own bait, tackle and fishing rod.
- If families are within the 6 feet of one another they must wear a mask.
- There will be fishing in both the lower lake and the upper lake.
- Fishing at the boat docks is prohibited.

Closing Ceremony and Checkout:

- Closing ceremony encourage families must remain 6 feet apart and wear masks.
- When trophy winners are approaching the presenter, they should be wearing face coverings
- Checking out, families should make way to their vehicles while staying 6 feet apart from other families.
